Trustees' Annual Report For the year ended 31 August 2024

The trustees present their report and receipts and payments accounts of the charity for the year ended 31 August 2024.

Structure, governance and management

The constitutional form of the charity is that of a Scottish Charitable Incorporated Organisation. The governing document is the constitution of the Whistleblowing International Network.

A majority of Trustees must come from and be elected by its members. The other remaining places are filled by appointment of the Board.

Objectives and activities

Charitable purposes

WIN's charitable purposes are to promote equality, justice, citizen engagement and ecological well-being, and to advance the human rights, education, health, and safety of people and their communities. It does this by strengthening the legal, technical, and strategic skills of civil society organisations around the world to protect whistleblowers.

WIN's Mission

To build, support, and strengthen a global civil society network that protects whistleblowers and promotes public interest accountability.

Activities

WIN's main activities to support its mission include:

- Developing, reinforcing, and mobilising the community of civil society organisations working on whistleblowing (outreach & mentoring, listserv, website, seminars, creating & participating in wider alliances)
- Advocacy and legal support (developing tools like the EU Whistleblowing Monitor, providing legal advice on draft laws, cases, campaigns, developing principles & standards-setting, advising and participating in regional & international bodies and fora)
- Education and communication (thematic reports, guidance and expertise for professional associations and other key stakeholders, and evaluation reports, etc)

Achievements and Performance

The importance of whistleblowing is recognised and featured in most major speeches, reports and inquiries into anti-corruption, protecting human and environmental rights and guarding against abuses of power in all sectors – whether governmental, financial, tech, mining, oil and gas, water management, agriculture, fishing, etc. However, knowledge as to how to work effectively with whistleblowers remains low. WIN continues to address the need to develop this expertise, to increase the number of specialist whistleblower protection organisations around the world and collaborate across borders, professions and industries to ensure whistleblowers are protected and that their disclosures make a difference.

In 2023-2024, as part of our plans to strengthen its expertise and advocacy impact, expand its geographical reach, and professionalise its structures and organisation to become a more resilient and effective global network, WIN conducted a thorough review of its activities and achievements and redrafted its strategy. It also continued to focus on strengthening the network and advocacy and developing tools and resources.

Highlights of WIN's work in 2023-24 include:

- Expanding the network to include 38 organisations spanning 5 continents.
- Reaching a wide audience with over 4,900 followers on LinkedIn and maintaining an up-todate website with news, events and resources on whistleblowing visited from 172 countries.
- Launching the first ever survey of civil society organisations working on whistleblowing around the world.

Reserves

WIN holds reserves, in the form of unrestricted funds to allow the charity to continue to operate for a period of time and meet potential liabilities in the event of loss or fluctuations in funding and cashflow. Unrestricted reserves can be spent on the furtherance of our charitable purpose, and decision making on this is at the discretion of our Trustees.

Donated services

The charity received donated services for ongoing hosting and support of its main website. Under normal market conditions at non-profit rates, the total costs of these donated services would have been approximately £1,930 (\$3,390).

Trustee remuneration and expenses

The trustees did not receive any remuneration from WIN during the year to 31 August 2024.

Plans for future periods

Our priority in early 2024 priority was to conduct an audit of WIN's activities and track record since WIN was formally established in 2018 and since our first practitioner's conference in September 2019 – with 75 delegates from 28 countries.

In 2025 we will publish a report on the work civil society is doing on whistleblowing on around the world and use it to work with our membership to refine our strategy, implement a new network-led priority and planning structure and organise the next WIN conference to be co-hosted with a membership organisation in 2025. This will be the second of WIN's triennial conferences, originally planned for 2022 but delayed due to the ongoing impact of COVID.

This work will lay the foundation to take WIN to the next level of its development as an expanded network, with greater capacity as a mobilised and committed community of the world's leading whistleblowing experts to effectively support public interest whistleblowers and each other, to uphold the rule of law, and defend and rebuild democratic accountability and good governance in an increasingly polarised and precarious world.

Financial Review

In the year to 31 August 2024 the charity had receipts of £83,992 (2023: £109,623) and payments of £78,487 (2023: £97,443), giving net receipts of £5,505 (2023: net receipts £12,180). Total funds under management at 31 August 2024 were £42,281 (2023: £36,776), of which £12,433 were restricted and £29,848 were held as unrestricted funds.

WIN had two core funding grants – a one year grant from the Charles Leopold Mayer Foundation (FPH) for €50,000EU, and the other from the Joffe Charitable Trust for £70,000 (2023-2025). The purpose of the core grants was to further develop WIN's activities, strengthen the network and develop its funding strategy. WIN also received a project grant from FPH in the year ended 31 August 2023. At 31 August 2024, this grant has £12,433 remaining to support a meeting on whistleblower protection in Switzerland. This is included in unrestricted funds carried forward.

Independent Examiner's Report For the year ended 31 August 2024

I report on the accounts of the charity for the year ended 31 August 2024, which are set out on pages 7 and 8 and the related notes on pages 9 to 11.

Respective responsibilities of trustees and examiner

The charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). The charity's Trustees consider that the audit requirement of Regulation 10(1) (d) of the Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the 2006 Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

1. Accounting policies

Basis of accounting

Funds continued

Nature and purpose of funds:

Unrestricted funds

WIN has two core funding grants - Charles Leopold Foundation (FPH) for €50,000EU (2024) for one year; and Joffe Charitable Trust for £70,000 over two years (1 March 2023 to 28 February 2025). The purpose of this core funding is to further develop WIN's activities, strengthen the network and develop its funding strategy.

Restricted funds

£12,433 held in the restricted fund relates to a project grant from FPH in the year ended 31 August 2023. At 31 August 2024, this grant has £12,433 remaining to support a meeting on whistleblower protection in Switzerland. This is included as restricted funds carried forward.

Transfers between funds: A transfer of £541 was made from unrestricted funds to ensure the balance carried forward at 31 August 2024 was the amount agreed to support the meeting as noted.
